**MEMORANDUM OF UNDERSTANDING
ON ACADEMIC EXCHANGE
BETWEEN**

**PhD School
Universidad Católica de Valencia
Valencia, Spain**

AND

**Department of Electrical Engineering
National Taipei University
New Taipei City, Taiwan**

With the objective of strengthening their mutual cooperation as well as striving for the promotion of mutual exchanges, PhD School, Universidad Católica de Valencia (hereafter referred to as UCV), and Department of Electrical Engineering, National Taipei University (hereafter referred to as NTPU) have concluded the following Agreement:

Article I – Scope of Cooperation

The areas of cooperation include, subject to mutual consent, any program offered at either institutions which both sides feel contributes to the fostering and development of cooperative relationship between the two parties.

Article II – General Areas of Cooperation

Cooperation shall be carried out, subject to the approval of UCV and NTPU, through such activities or programs related, but not limited to:

1. Promotion of joint research and educational activities
2. Invitation to short-term visits of faculty members and researchers for lectures, conferences, colloquia, and symposia or other academic activities
3. Exchange of information and pertinent publication in fields of interest to both universities
4. Exchange of faculty members, researchers and students for study and research

Article III – Establishment of Program and Activities

The term of individual programs and activities shall be mutually discussed and agreed upon in writing by both parties prior to their initiation.

Article IV – Program Liaison Representatives

Each party will designate an individual to act as program liaison for the program. This program liaison will act as advisor in academic and logistical matters.

Article V – Term, Termination, and Amendments

The agreement will go into effect from the date of the last signature and will be in effect for **5 years**. Both parties reserve the right to terminate this agreement upon written notice given 6 months.

Any additions, changes, or deletions must be approved in writing by official representatives of both institutions.

Article VI – Administration

Administration of this agreement shall be the responsibility of the UCV and NTPU

The present agreement is signed in two (2) copies, and each party will keep one copy. All the activities carried out under the terms of this agreement shall be separately negotiated and determined by both institutions, subject to availability of resources, giving consideration to the special strengths and limitations of each institution. Such cooperative agreement is not intended to be a legally binding document, but rather is intended to describe the nature and the guidelines for mutually beneficial cooperation. Nothing, therefore, shall diminish the full autonomy of either institution, in carrying out the agreement.
